Dr Correa:

Apologies for not responding to you at the timelines you expected. I did have to ensure a due diligence based on a full understanding of where GO/Metrolinx is relative to the Province's Transitway EA process and the status of the other key rapid transit projects planned.

So my understanding is that the provincial 407 Transitway. EA proposes a transit station at the area in question, with a GO platform that extends between the 407 and Hwy 7. This proposal would enable the seamless integration between a possible future 407 Transitway and the York Viva Bus Rapid Transit along Hwy 7.

As such, there do not appear any transportation advantage to exploring a station on the north side of Hwy 7. In the case of consideration of timing, the 407 Transitway is a long term proposition while the York Viva Hwy 7 BRT is a nearer term project.

So even when considering a temporary station facility to meet the needs of the Hwy 7 rapid transit, a location to the south side of the right-of-way future-proofs for the possibility of the 407 Transitway being implemented and therefore a preferred location.

Thank you for raising the concerns of the West Concord community. I recommend you continue to have an open dialogue with the province on the environmental issues you raised.

Metrolinx remains committed to advancing the transformation of the GTHA with a seamlessly integrated transportation network.

It will be a very long time before the 407 Transitway becomes a reality (possibly decades) however the Hwy 7 York Viva BRT is a funded project that will be in service within the next 2 - 5 years and therefore having a station where the GO rail corridor and the BRT intersect sooner would make more sense.

At this time I cannot comment on which specific site closer to Hwy 7 is the best without undertaking a more detailed planning review. So in principle a site closer to the Hwy 7 corridor is preferable, which specific site I cannot comment on

I am a bit unclear as to what you said below. Can you confirm that a location on the north side of Highway 7 will do just as well for your purposes, whether short-term or long-term?

The community is not concerned whether the exact location that the suggested (we actually proposed two alternate locations for the GO station, both on the north side of Highway 7) is accepted, only on the exclusion of the location on the south side, on an ecologically sensitive area that serves as the green space to the community.
