Dear Premier McGuinty,

Our M.P.P., Peter Shurman, graciously offered to deliver to you a request to grant a short (15-20 minute) audience to the below-signed Dr. Correa, Mrs. Mastrodicasa and Mrs. Bacchin, representatives of the Concord West community, so that we can propose to you a solution to a very serious problem raised by the current planning for the 407 Transitway - a solution that would be of mutual benefit to the Province, our community and your government. We have tried before to request such an audience through the intercession of Mr. Monte Kwinter and Mayor Maurizio Bevilacqua. Not having succeeded for a variety of reasons, we now try to address ourselves to you directly, since we reason that no one else will take our case to Cabinet other than, hopefully, you.

The problem concerns (1) the planned location of an intermodal station on greenland that should be protected – for both its ecology (including a Protected species found there) and its critical location at the confluence of Upper Don tributaries – and (2) the destructive impact of such a hub upon the integrity of our community.

We do not expect your Minister of Transportation to take up our case in Cabinet, as she would have to go against the (wrong, in our view) conclusions of her own ministerial team headed by Mr. Minnes. And likewise we do not expect your Minister of the Environment to take up our case, as we just found out that on February 28th he approved the 407 Transitway EPR, to which our community had filed an Objection (herein attached), without so much as informing us of it. But since, on February 15th, 2011, the Vaughan City Council unanimously passed a resolution (herein attached) requesting from the Province a proper assessment (which the MTO did *not* carry out) of the Alternative Plan put forth by the Concord West

community and spearheaded by the Seniors Club, we have no one left to turn to but you. Please accord us the chance to explain to you the win-win advantages of Cabinet adopting the Alternative Plan of the Concord West community.
